RELEASE OF LIABILITY, WAIVER OF ALL POSSIBLE CLAIMS AND ASSUMPTION OF RISK
PLEASE READ CAREFULLY

I desire to have my child participate as a member of Boys and Girls Club of Airdrie. I understand that in order to participate in membership programs and activities, I must **AGREE TO BE BOUND BY THE RELEASE, WAIVER AND ASSUMPTION OF RISK.**

LIABILITY WAIVER AND RELEASE: In consideration of acceptance of my child's participation in the Boys and Girls Club of Airdrie membership programs and activities, I waive any and all claims I may now and in the future have against, and **RELEASE FROM ALL LIABILITY AND AGREE NOT TO SUE**, Boys and Girls Club of Airdrie, its directors, officers, employees, volunteers, agents, representatives and (collectively it's staff), for: **ANY PERSONAL INJURY, DEATH, PROPERTY DAMAGES AND EXPENSES OR LOSS** sustained by my child, or myself, as a result of my child's attendance at and participation as a member of Boys and Girls Club of Airdrie, **DUE TO ANY CAUSE WHATSOEVER**, including without limitation negligence or breach of statutory duty including duties arising from liability legislation on the part of Boys and Girls Club of Airdrie or its staff. In addition, I grant permission to administer any medical treatment that may be required.

I agree to **INDEMINIFY AND HOLD HARMLESS** Boys and Girls Club of Airdrie and its staff from any and all claims, demands, actions and costs (including legal costs on a solicitor-client basis) which may arise from my child participating in Boys and Girls Club of Airdrie membership programs and activities, even though such claims, demands, actions and costs may have been caused by the negligence of Boys and Girls Club of Airdrie or its staff.

In entering into this agreement, I am not relying on any oral, written or visual representations or statements made by Boys and Girls Club of Airdrie or its staff.

RISK: I, the undersigned, understand and acknowledge that my child's participation in Boys and Girls Club of Airdrie membership programs and activities might result in **POSSIBILITY OF PERSONAL INJURY, DEATH, and PROPERTY DAMAGE OR LOSS.** I further understand and acknowledge that Boys and Girls Club of Airdrie do not provide waiting paramedics, and medical facilities may not be readily available. I fully understand these risks and hereby agree to my child participating in the Boys and Girls Club of Airdrie membership programs and activities.

I confirm that I am the parent or guardian of the minor participant named, and that I have read and understand this agreement prior to signing it and agree that this agreement is binding upon myself (as a parent, guardian or participant) my heirs, next of kin, executors, administrators and successors.

I, as the parent or guardian of the minor participant named herein, I agree to assume full responsibility to instruct my child of the risks involved, and to inform him or her of the importance of abiding by the rules and Code of Conduct.

A positive and safe environment is essential for members to succeed. A positive environment means everyone feels they are welcome and respected. All members, parents, volunteers and staff have the right to be safe, and feel safe, in their Club. With this right comes the responsibility for everyone to be accountable for their actions and contribute to a positive environment.

The Boys and Girls Club of Airdrie is dedicated to provide a safe, supportive place where children and youth can experience new opportunities, overcome barriers, build positive relationships and develop confidence and skills for life. As a parent/ guardian of a Boys and Girls Club of Airdrie participant all members and parents/ guardians are required to abide by the Code of Conducts and behave in a fashion that promotes themselves and their Club in a positive manner.

Boys and Girls Club of Airdrie parents/ guardians and members will:

- Treat members, parents, staff, volunteers and others with respect, courtesy and consideration.
- Avoid and prevent put-downs, insults, name calling, yelling and other verbal and non-verbal conduct likely to offend, hurt or set a bad example.
- Help to create a safe environment, not carelessly or intentionally harming children/ youth or adults in any way: verbally, mentally, or physically.
- Resolve conflicts in a way that is civil and respectful, without using violence. Physical aggression is not a responsible way to deal with other people. No one should use physical aggression to injure another person, or even threaten to injure another person. This is unacceptable and puts everyone's safety at risk.
- Follow Boys and Girls Club of Airdrie policies and procedures when your child/ youth is participating in any Boys and Girls Club of Airdrie program/ event.

The Boys and Girls Club of Airdrie is committed to building an environment free of bullying, racism, sexual harassment, substance abuse and disrespectful behavior. Staff and volunteers are to take preventative measures at all times and are to intervene appropriately to address situations as they occur. Cases that cannot be resolved may result in removal of a non-compliant participant or parent/ guardian from a program or facility.
